1. Acceptance of Terms

2. Changes to Terms

We reserve the right to modify these Terms at any time. We will notify you of any changes by posting the new Terms on this page. Your continued use of Konexion after any such changes constitutes your acceptance of the new Terms.

3. Privacy Policy

Your use of Konexion is also governed by our Privacy Policy, which is incorporated into these Terms by reference.

4. User Accounts

4.1 You must create an account to use Konexion. You are responsible for maintaining the confidentiality of your account and password.

4.2. You agree to provide accurate, current, and complete information during the registration process and to update such information to keep it accurate, current, and complete.

4.3. You agree to link your Instagram account to Konexion. This link is used to enhance your user experience and calculate your user value within the app.

5. User Conduct
